I, the adult or child under 18 (with the required consent of a parent/guardian), in order to participate and become a client of RGV ALL STARS SPORTS GYM, LLC AND ANY OF ITS AFFILIATES, acknowledge and agree to all the following terms and conditions of this waiver of liability:

Assumption of Risk:

I acknowledge that using gym facilities, and equipment, and participating in physical exercise involves inherent risks, including but not limited to physical injury, strain, discomfort, and the possibility of serious injury or death. I, the registered client, assume all risks and responsibility for any injuries or other medical incidents.

Waiver and Release:

I hereby release, waive, discharge, and agree not to sue the Provider, its employees, representatives, affiliates, or agents for any claims, demands, liabilities, rights, damages, expenses, and causes of action of any nature arising from my use of the gym facilities, whether caused by the negligence of the Provider or otherwise.

Medical Representation:

I represent that the client is physically fit to use the gym facilities and participate in physical exercise. I, the registered client, have no medical condition that would prevent safe participation. If there are any medical conditions or concerns toward myself, said client, they have consulted with a healthcare provider and obtained clearance to participate.

Rules and Regulations:

I will abide by all rules, regulations, and policies of the Provider, including proper use of equipment, following safety guidelines, and respecting other clients and staff.

Consent to Medical Treatment:

I give consent to receive any necessary medical treatment resulting from my use of the gym facilities and agrees to bear all costs associated with such treatment. In the event of illness or accident, I, the said client, give consent to be treated by qualified medical personnel and let said personnel to secure any and all necessary emergency/regular medical care for the injured recipient.

Gym Facility:

I acknowledge that the facility has zero tolerance with weapons, alcohol, drugs and bullying. I will respect the gym facility itself along with the coaches, staff, players, referees, and parents. I, the registered client of RGV ALL STARS SPORTS GYM, LLC, agree to not bring food or drinks to the gym, other than water.

Your Personal Content:

Any pictures and/or videos of members in the facilities will give RGV ALL STARS SPORTS GYM, LLC the right to use for media and marketing purposes.

Loss or Breakage of Personal Items:

Any loss or breakage of personal items while using the gym space is not liable for RGV ALL STARS SPORTS GYM, LLC, and it is up to the client to handle and find said items. Clients can justify lost items through blind description and returned to them if administration seems description is fit. After one month of lost items not being claimed, they will be disposed.
